May 2-17 NWEA Testing grades K-2 iPads in individual rooms

Accuplacer is an optional assessment for sophomore, junior, and senior students. The test is used for placement of students in college credit classes, both online classes and college in the high school classes. The test is also used for English and mathematics placement for students attending two-year community and technical colleges. The test is untimed and students may leave the test when they have finished. Students may not bring a calculator to this test, if one

is to be used it will be available online for the students. All students take the English portion of the test and the arithmetic portion of the test. If students pass the arithmetic test, an elementary algebra test will open up. If the elementary algebra test is passed, a college math test will open. For students to complete all four tests, it takes approximately three hours. Additional information about the test can be found at <https://accuplacer.collegeboard.org/?excmid=VT-00002>. The results will be available immediately upon completing of the test. The student will be given a paper copy of the results immediately, along with the results being put in the student cumulative folder in the office and results will be recorded on the student transcript.

Pre-ACT is an optional assessment for sophomore and junior students. The students pay \$12 to take the test. The test is administered 1<sup>st</sup>-4<sup>th</sup> hours of the day. The test is very similar to the ACT and includes reading, English, mathematics, and science subtests. After completing the test, the students will be able to use ACT Online Prep to continue preparing for the ACT. The test is timed and students may use a calculator on the mathematics portion of the test. Paper copies of the results from the test will be distributed to students during the school day approximately one month after completing the test.

ACT is an optional assessment for junior students. The state pays the cost of the test, \$58.50. All students are encouraged to take the test. The test lasts approximately 4 hours and includes a reading, English, mathematics, science, and writing subtests. The test is timed and students may use a calculator on the mathematics portion of the test. Any special accommodations must be applied for in advance through the testing coordinator. Proper documentation is required and will need to be submitted to ACT for approval. The purpose of the test is to provide Minnesota graduates information related to career and college readiness. The rationale for the test is Minnesota Statute 120B.30. The test results may be used for college/university entrance and placement. For additional information about the test, please visit [www.act.org](http://www.act.org). Results from the test will be mailed directly to the student from ACT approximately six weeks after the test. The school district will also receive a copy of the results, plus the district will receive a sticker to put on the student cumulative folder. The results will be entered on the student transcript.

MCA and MTAS are the Minnesota state assessments in the areas of mathematics, reading/language arts, and science. The tests are given over a two day period, with three hours

blocked out each day for the students to take the tests. The tests are untimed and if students need additional time, it will be given. The purpose of the assessments are to measure achievement on the Minnesota Academic Standards and measure academic progress of students over time. The rationale for the tests is Minnesota Statutes 120B.30 and ESEA. Results from the tests will be told to students within a week. Unofficial results will be mailed to parents with the end of the year report cards in the summer. Official results will be distributed to parents in the fall either at Open House or Fall Parent-Teacher Conferences after the district receives the official mailing from MDE. There will also be result stickers put on the student cumulative folder. Special accommodations for the tests can be made through special arrangements with the special education teachers and/or testing coordinator.

Mathematics MCA: Grade level is in the first column followed by the number of questions per section on the test. Students will be completing sections 1-3 on day one and sections 4-5 on day two. Even though the estimated test administration time is 1.5-2.5 hours, there will be 3 hours each day scheduled for the administration of the test.

ASVAB – Military aptitude test given to all juniors. Students can opt out of taking the test. The test is a multiple-aptitude battery of tests which includes reading and mathematics subtests, in addition to mechanics, electronics, and carpentry. Additional information about the test and tips on preparing for the test can be found at <http://official-asvab.com/>. The test is timed, no calculator is allowed on the test. The test is scheduled for the first four hours of the day. The results will be explained to students by a member of the military approximately two weeks after the test date. The students will be given a summary sheet and a special login where they can access their scores and interest inventory information. Students can continue to use the website in the future if they desire. Students interested in entering the military use the score for placement in the military. Other students can use the score as an indicator for the ACT.

NWEA – District computerized assessment given to students in grades K-2 in the spring and fall and students in grade 3 in the fall for math and reading. Additional information about the NWEA can be found at <https://www.nwea.org/>. Results from the fall administration of the test will be discussed at fall parent-teacher conferences. Printed copies of the fall and spring results will be mailed with the final report cards in the summer.
